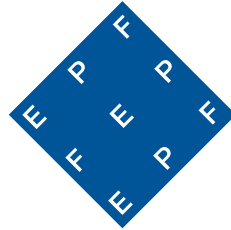
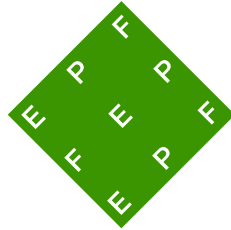
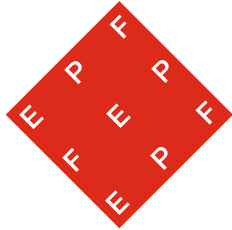

ARGUMENT OF THE EPF ANNUAL CONFERENCE 2025 IN DRESDEN

FREEDOM

Dear Colleagues,

We are delighted to welcome you to the 38th Annual Conference of the EPF in Dresden where we have moved from Florence 2024 to "Florence on the Elbe" 2025. When you visit Dresden, you will realise that both its outstanding art collections, several buildings that characterise the cityscape and its geographical location on the Elbe have contributed to this reputation.

We have chosen "Freiheit - Freedom - Liberté" for this year's theme. We are continuing the tradition of the recent congresses, in which we were also inspired by a central notion for the various contributions: Realities (2021) - Ideals (2022) - Illusions (2023) - Identifications (2024). The theme of Freedom resonates with the numerous European crises. Our personal freedom as well as the freedom of our global European society is currently under threat by a range of different sociopolitical scenarios. We will reflect these scenarios in the individual contributions to our congress: all the more as they push into our consulting room and preoccupy us increasingly in our psychoanalytical federation, the EPF.

What does psychoanalysis have to say on the subject of 'freedom'? How is the concept of freedom related to the unconscious? How does it apply to clinical psychoanalysis and advance metapsychology? In Freud's work, there are at least two thematic formulations in which the concept of freedom is highlighted. The first topic concerns the relationship between freedom and determinism. How free are we actually to choose and how much are our actions determined by our unconscious? In dream formation Freud writes:

"There is far less freedom and arbitrariness in mental life than we are inclined to assume; there may even be none at all" (Freud 1907 9); and when analysing parapraxes and slips, he speaks of the "illusion of such a thing as psychological freedom" (Freud 1916 49), which forbids us to regard slips of the tongue and other mistakes that are unconsciously motivated. These formulations by Freud cannot and should not surprise us, because without the assumption of psychic determination by the unconscious, dreams and parapraxes would be arbitrary, even random, and in any case unmotivated mental products. Thus psychoanalysis would be deprived of its foundations that is its *raison d'être* in the first place.

It would be just as far-reaching to believe that a causal determinism emanates from the un-

conscious. How could the analytic treatment lead to anything other than the parodistic explanation of the past through the present? Molière ingeniously and simply put it in the following phrase from his comedy *The doctor in Spite of Himself*: "And you see, that's why your daughter is mute". Freud's concept of the *après-coup* in particular - that only in the future will it become clear what the past is all about - cannot be conceived of without a minimum degree of psychological freedom. By no means must it be misunderstood as an explanation of the predetermination of our psychic life by early childhood influences. Laplanche in particular did a great deal to keep the *après-coup* free of any overly simplistic determinism, which is especially included in the English translation as "deferred action". But also Freud's description of the "effectiveness of analysis", namely that it should "give the patient's ego the freedom to decide one way or the other" (Freud 1923, 50, footnote 1, bold in original) would be untenable without the assumption of a certain psychological freedom.

And is it not a characteristic of the psychoanalytic vocabulary that it cannot work without an element of freedom? Isn't this the reason why 'overdetermination' belongs to this vocabulary and simple 'determinism'? It's not by chance that we call our fundamental rule 'free association'. The tension between freedom and determinism which we just described is inherent in the notion itself.

The second thematic formulation deals with the meaning of freedom within Freud's theory of culture, as he developed it, for example, in "Civilization and its Discontents". In the context of his reflections on why our cultural life seems to impose all too many obstacles on the human pursuit of happiness, Freud also addresses freedom, or more precisely "the liberty of the individual", a *liberté*. It is precisely this instinctual freedom that distinguishes the human "animal organism" (ibid. 105, footnote 2) from the termites, which are selflessly absorbed in their social function within an insect state, while the human instinctual being has an a-social side anchored in infantile sexuality, that is difficult to tame. How can we profitably take up Freud's far-reaching reflections on the relationship between freedom and culture at a time when the "discontent" in culture is palpable and is becoming more and more widespread from day to day?

Of the many authors who, inspired by Freud, have turned to the concept of freedom, let us single out Winnicott, who wrote two short, less recognized texts entitled "Freedom". Winnicott addresses the problem of psychological determinism, "...it is obviously very difficult...

perhaps for all human beings, to accept determinism as a basic fact" (Winnicott, "Freedom", 1969-1971, 80), with certain "environmental conditions" that contribute to the subjective feeling of freedom. He primarily focuses on severely disturbed patients whose inner freedom is restricted by mental illness. His deep humanism is reflected in the final sentence of one of the two essays, in which he ponders the background to happiness, health and freedom: "Those who are well enough and free enough must be able to endure the triumph which belongs to their state. Yet nothing but luck gave them the chance to be healthy" (Winnicott, "The Threat to Freedom", 1969-1971, 87).

Beyond these few suggestions, we would like to invite you to take the liberty of thinking about freedom in and beyond psychoanalysis, and to attend the congress of the EPF 2025 in Dresden. So much has been left unsaid in this brief argument - especially the connection of our topic to the neighbouring sciences of psychoanalysis such as philosophy and art, literature and politics, so that your help in dealing with the topic of freedom is indispensable. Dresden seems to us to be exactly the right place for this: the city represents both the loss and regaining of freedom. In addition, it offers a variety of attractions that can easily be linked to our congress theme.

We very much look forward to welcoming you to the International Congress Centre, Maritim Hotel, for the 38th EPF Conference 2025.

ARGUMENT DER EPF-JAHRESKONFERENZ 2025 IN DRESDEN

FREIHEIT

Liebe Kolleginnen, liebe Kollegen,

wir freuen uns sehr, Sie zur 38. Jahreskonferenz der EPF in Dresden begrüßen zu dürfen. Wir sind von Florenz 2024 nach „Elbflorenz“ 2025 weitergezogen. In Dresden werden Sie feststellen, dass sowohl herausragende Kunstsammlungen wie auch das Stadtbild prägende Bauwerke und die geographische Lage an der Elbe zu dieser Auszeichnung beigetragen haben.

Als Thema haben wir dieses Jahr „Freiheit – Freedom – Liberté“ gewählt. Damit setzen wir die Tradition der letzten Kongresse fort, in denen wir uns ebenfalls von einem Begriff zu verschiedenen Beiträgen haben inspirieren lassen: Realitäten (2021) – Ideale (2022) – Illusionen (2023) – Identifizierung (2024). Im Thema der Freiheit schwingen die zahlreichen Krisen in Europa mit. Unsere persönliche Freiheit wie auch die Freiheit unserer globalen europäischen Gesellschaft ist durch verschiedene soziopolitische Szenarien bedroht. Wir werden diese Szenarien in den einzelnen Veranstaltungen unseres Kongresses reflektieren, umso mehr, als sie verstärkt in unsere Behandlungsräume drängen und uns auch zunehmend in unserer psychoanalytischen Föderation, der EPF, beschäftigen.

Doch was hat die Psychoanalyse zum Thema ‚Freiheit‘ zu sagen? Wie hängen die Begriffe Freiheit und Unbewusstes zusammen? Wie ragt der Begriff Freiheit in die klinischen Behandlungen hinein und wie lässt er sich metapsychologisch fassen? Bei Freud gibt es zumindest zwei Themenkomplexe, in denen der Begriff Freiheit großes Gewicht hat. Der erste Komplex betrifft die Beziehung zwischen Freiheit und Determinismus. Wie frei sind wir in unseren Willensentscheidungen und wie sehr werden wir dabei von unserem Unbewussten determiniert? So schreibt Freud etwa im Kontext der Traumbildung:

„Es gibt viel weniger Freiheit und Willkür im Seelenleben, als wir geneigt sind anzunehmen; vielleicht überhaupt keine“ (GW VII 33); und bei der Analyse der Fehlleistungen spricht er von der „Illusion der psychischen Freiheit“ (GW XI 42), die es verbiete, Versprecher und andere Fehlleistungen als unbewusst motiviert zu betrachten. Diese Formulierungen Freuds können und dürfen uns nicht überraschen, denn ohne die Annahme einer psychischen Determinierung durch das Unbewusste würden sich Traum und Fehlleistungen eben als willkürliche, ja zufällige, auf jeden Fall unmotivierte geistige Produkte erweisen. Die Psychoanalyse wäre der Grundlage beraubt, welche ihr überhaupt erst eine Existenzberechtigung verleiht.

Genauso folgenreich wäre es zu glauben, vom

Unbewussten ginge eine strenge, eine kausale Determinierung aus. Wie könnte dann die Analyse zu etwas anderem führen als zu jener parodistischen Erklärung der Vergangenheit durch die Gegenwart, wie sie Molière genial einfach im folgenden Satz aus seiner Komödie *Der Arzt wider Willen* festgehalten hat: „Und sehen Sie, deshalb ist Ihre Tochter stumm“. Insbesondere Freuds Begriff der Nachträglichkeit – dass sich erst in der Zukunft erweisen wird, was es mit der Vergangenheit auf sich hat – lässt sich nicht ohne ein Mindestmaß an psychischer Freiheit denken und darf keineswegs als Erklärungsmuster für die Vorherbestimmtheit unseres Seelenlebens durch frühkindliche Einflüsse missverstanden werden. Besonders Laplanche hat sich darum verdient gemacht, die Nachträglichkeit von jedem allzu simplen Determinismus freizuhalten, wie er in der englischen Übersetzung der Nachträglichkeit als „deferred action“ implizit enthalten ist. Aber auch Freuds Beschreibung der „Wirkung der Analyse“, dass sie „dem Ich des Kranken die Freiheit schaffen soll, sich so oder anders zu entscheiden“ (GW XIII 280 Fußnote 1, Hervorhebung i.O.) wäre ohne die Annahme einer bestimmten psychologischen Freiheit nicht haltbar.

Und ist es nicht ein Merkmal des gesamten psychoanalytischen Vokabulars, dass es ohne ein Element von Freiheit nicht funktionieren kann? Ist das nicht der Grund dafür, dass ‚Überdeterminierung‘ zu diesem Vokabular gehört, der einfache ‚Determinismus‘ hingegen nicht? Nicht zufällig nennen wir unsere Grundregel ‚freie Assoziation‘. Die Spannung zwischen Freiheit und Determinismus, die wir gerade beschrieben haben, ist dem Begriff selbst eingeschrieben.

Beim zweiten Themenkomplex geht es um die Bedeutung der Freiheit innerhalb von Freuds Kulturtheorie, dafür wählen wir beispielhaft „Das Unbehagen in der Kultur“. Im Kontext seiner Überlegungen, warum unser Kulturleben dem menschlichen Glücksstreben allzu viele Hindernisse aufzubürden scheint, kommt er auch auf die Freiheit zu sprechen, genauer gesagt auf die „individuelle Freiheit“ und behauptet: „Die individuelle Freiheit ist kein Kulturgut“ (GW XIV 455), um in der Folge den ewigen Konflikt zwischen individuellem Freiheitsanspruch und kulturellen Ge- und Verboten hervorzukehren. Nein, sagt Freud in der gleichen Passage, es scheint unmöglich, die Natur des Menschen „in die eines Termiten umzuwandeln, er wird wohl immer seinen Anspruch auf individuelle Freiheit gegen den Willen der Masse verteidigen“ (ebd. 456). Unter individueller Freiheit versteht Freud hier vor allem und zunächst „Triebfreiheit“ (ebd. 474), die durch die Auflagen der Kultur nachhaltig eingeschränkt, ja geschädigt würde. Genau diese individuelle Freiheit unterscheidet das „Tierwesen“ (ebd. 465) Mensch von den Termiten, die innerhalb ihres Insektenstaates selbstlos in ihrer sozialen

Funktion aufgehen, während das Triebwesen Mensch eine in der infantilen Sexualität wurzelnde a-soziale Seite hat, die nur schwer zu bändigen ist. Wie können wir Freuds weitreichende Überlegungen zum Verhältnis von Freiheit und Kultur gewinnbringend aufgreifen in einer Zeit, in der das „Unbehagen in der Kultur“ mit Händen zu greifen ist und von Tag zu Tag größer zu werden droht?

Aus der Vielzahl von Autoren, die sich, von Freud inspiriert, dem Begriff der Freiheit zugewandt haben, sei auf Winnicott hingewiesen, der zwei kurze, weniger beachtete, Texte mit dem Titel „Freedom“ verfasst hat. Winnicott weist darin sowohl auf das Problem des psychischen Determinismus hin, „es ist ganz offensichtlich sehr schwierig, vielleicht für alle Menschen, den Determinismus als eine grundlegende Tatsache zu akzeptieren“ (Winnicott, „Freedom“, 1969–1971, 80; Übersetzung U.H.), als auch auf „Umweltbedingungen“, die auf das subjektive Freiheitsgefühl einwirken. Im Blick hat er dabei vornehmlich schwer gestörte Patienten, deren innere Freiheit durch psychische Erkrankung eingeschränkt ist. Sein tiefer Humanismus zeigt sich im Schlusssatz eines der beiden Aufsätze, in dem er über die Hintergründe von Glück, Gesundheit und Freiheit nachdenkt: „Diejenigen, denen es gut genug geht und die frei genug sind, müssen in der Lage sein, den Triumph auszuhalten, der zu diesem Zustand gehört. Dennoch, nichts als Glück gab ihnen die Möglichkeit, gesund zu sein“ (Winnicott, „The Threat to Freedom“, 1969–1971, 87; Übersetzung U.H.).

Wir möchten Sie gerne dazu einladen, über diese Anregungen hinaus sich selbst die Freiheit zu nehmen, über Freiheit in und jenseits der Psychoanalyse nachzudenken und dafür unseren Kongress 2025 in Dresden zu besuchen. Vieles ist ungesagt geblieben in diesem kurzen Argument – insbesondere die Verbindung von Freiheit zu den Nachbarwissenschaften der Psychoanalyse wie der Philosophie und der Kunst, der Literatur und der Politik –, sodass Ihre Mithilfe bei der Beschäftigung mit der Freiheit unabdingbar ist. Dresden scheint uns dafür genau die richtige Stadt zu sein: Sie steht gleichermaßen für Verlust wie auch für wiedergewonnene Freiheit und lockt mit vielfältigen attraktiven Angeboten, die sich zwanglos in Verbindung zu unserem Kongress Thema bringen lassen.

Wir freuen uns sehr, Sie im Maritim Hotel & Internationales Congress Center Dresden zur 38. Jahreskonferenz der EPF 2025 willkommen zu heißen.

ARGUMENT DE LA CONFÉRENCE ANNUELLE DE LA FEP 2025 À DRESDE

LIBERTÉ

Chères collègues, chers collègues,

Nous sommes très heureux de vous accueillir à Dresde pour la 38^e conférence annuelle de la FEP. Nous passons donc de Florence 2024 à la « Florence de l'Elbe » 2025. En visitant Dresde, vous constaterez que ses collections d'art exceptionnelles, ses différents monuments marquant le paysage urbain ainsi que sa situation géographique au bord de l'Elbe ont contribué à cette distinction.

Cette année, nous avons choisi comme thème « Freiheit - Freedom - Liberté ». Nous poursuivons ainsi la tradition des derniers congrès, au cours desquels nous nous sommes également laissés inspirer par un seul mot pour les différentes contributions : Réalités (2021) - Idéaux (2022) - Illusions (2023) - Identification (2024). Dans le thème de la liberté résonnent les nombreuses crises en Europe. Notre liberté personnelle ainsi que la liberté de notre société européenne globale sont menacées par des scénarios socio-politiques très différents. Nous tenterons de réfléchir lors des différents événements de notre congrès à la façon dont ces scénarios s'imposent progressivement dans nos cabinets et nous préoccupent également de façon croissante au sein de notre fédération psychanalytique, la FEP.

Mais que la psychanalyse a-t-elle à dire sur le thème de la 'liberté' ? Et quel est le lien entre la notion de liberté et celle d'inconscient ? Cette notion de liberté, comment s'insère-t-elle dans les traitements cliniques et comment peut-elle être saisie métapsychologiquement ?

Chez Freud, il y a au moins deux problématiques dans lesquelles le concept de liberté est d'une grande importance. La première concerne la relation entre la liberté et le déterminisme. Dans quelle mesure sommes-nous libres dans nos décisions et nos choix, et dans quelle mesure sommes-nous déterminés par notre inconscient ? Ainsi, dans le contexte de la formation des rêves, Freud affirme : « Mais il y a beaucoup moins de liberté et d'arbitraire dans la vie d'âme que nous ne sommes enclins à l'admettre ; il n'y en a peut-être pas du tout. » (OCP VIII 45) et dans l'analyse des actes manqués, il parle de « l'illusion d'une liberté psychique » (OCP XIV 44), qui interdit de considérer les lapsus et autres actes manqués comme étant motivés inconsciemment. Ces formulations de Freud ne peuvent et ne doivent pas nous surprendre, car sans l'hypothèse d'une détermination psychique par l'inconscient, le rêve et les actes manqués se révéleraient comme des produits mentaux arbitraires, voire accidentels, en tout cas non motivés. La psychanalyse serait privée de la

base qui lui donne sa raison d'être.

Mais il serait tout aussi lourd de conséquences de croire que l'inconscient est à l'origine d'une détermination causale. Comment l'analyse pourrait-elle alors aboutir à autre chose qu'à cette explication parodique du passé par le présent, telle que Molière l'a génialement et simplement consignée dans cette phrase de sa comédie *Le médecin malgré lui* : « Et voilà pourquoi votre fille est muette ». La notion d'après-coup chez Freud - selon laquelle seul l'avenir offrirait la preuve du passé - ne peut être pensée sans un minimum de liberté psychique et ne doit en aucun cas être interprétée comme un modèle d'explication de la prédétermination de notre vie psychique par des influences de la petite enfance ; c'est à Laplanche en particulier que revient le mérite de préserver l'après-coup de tout déterminisme trop simpliste, comme par exemple indiqué dans la traduction anglaise de l'après-coup par « deferred action ». Et la description même que fait Freud de « l'effet de l'analyse », à savoir qu'elle doit « procurer au moi du malade la liberté de se décider pour ceci ou cela » (OCP XVI 293 note de bas de page 1.) ne serait pas tenable sans l'hypothèse d'une certaine liberté psychique.

Et n'est-ce pas une caractéristique de tout le vocabulaire psychanalytique que de ne pas pouvoir fonctionner sans un élément de liberté ? N'est-ce pas la raison pour laquelle la 'surdétermination' fait partie de ce vocabulaire, alors que le simple 'déterminisme' n'en fait pas partie ? Ce n'est pas par hasard que nous appelons notre règle de base 'association libre' : la tension entre liberté et déterminisme que nous venons de décrire est inscrite dans le terme lui-même.

La deuxième problématique porte sur l'importance de la liberté dans la théorie culturelle de Freud, prenons par exemple « Le Malaise dans la culture ». Dans le contexte de ses réflexions sur les raisons pour lesquelles notre vie culturelle semble imposer trop d'obstacles à l'aspiration humaine au bonheur, Freud aborde également la question de la liberté, plus précisément celle de « liberté individuelle », et affirme que « la liberté individuelle n'est pas un bien de culture » (OCP XVIII p.283), pour ensuite mettre en évidence l'éternel conflit entre la revendication de liberté individuelle et les interdictions, mais aussi les prescriptions culturelles. Non, dit Freud dans le même passage, il semble impossible de transformer la nature de l'homme « en celle d'un termite, l'homme défendra sans doute toujours sa revendication de liberté individuelle contre la volonté de la masse » (ibid. 283). Par liberté individuelle, Freud entend ici avant tout la « liberté pulsionnelle » (ibid. 284), qui serait pour ainsi dire durablement limitée, voire endommagée par les contraintes de la culture. C'est précisément cette liberté individuelle qui distingue l'être animal humain (ibid. 292) des termites, qui s'investissent

sans restriction dans leur fonction sociale au sein de leur état d'insectes, tandis que l'être pulsionnel humain a un côté a-social, enraciné dans la sexualité infantile, qui est difficile à maîtriser. Comment pouvons-nous profitablement reprendre les considérations approfondies de Freud sur le rapport entre la liberté et la culture à une époque où le « malaise dans la culture » est palpable et menace de s'amplifier de jour en jour ?

Parmi les nombreux auteurs qui, inspirés par Freud, se sont tournés vers la notion de liberté, je voudrais retenir Winnicott, auteur de deux courts textes peu connus, intitulés « Freedom ». Winnicott y aborde à la fois le problème du déterminisme psychique, « il est de toute évidence très difficile, peut-être pour tous les êtres humains, d'accepter le déterminisme comme un fait fondamental » (Winnicott, « Freedom », 1969-1971, 80 ; traduction U.H.), et celui des « conditions environnementales » qui influent sur le sentiment subjectif de liberté. Il s'intéresse principalement aux patients gravement perturbés, dont la liberté intérieure est limitée par la maladie psychique. Son profond humanisme transparaît dans la phrase finale de l'un des deux essais, dans laquelle il réfléchit aux fondements du bonheur, de la santé et de la liberté : « Ceux qui vont suffisamment bien et qui sont suffisamment libres doivent être en mesure de supporter le triomphe qui fait partie de cet état. Pourtant, rien d'autre que la chance ne leur a donné la possibilité d'être en bonne santé » (Winnicott, « The Threat to Freedom », 1969-1971, 87 ; traduction U.H.).

Nous aimerions vous inviter, au-delà de ces quelques suggestions, à prendre la liberté de réfléchir sur la liberté dans et au-delà de la psychanalyse et à participer pour cela à notre congrès 2025 à Dresde. Tant de choses n'ont pas été dites dans ce bref argument - en particulier le lien de la liberté avec les sciences voisines de la psychanalyse, comme la philosophie, l'art, la littérature et la politique - de sorte que votre aide est indispensable pour l'étude approfondie du thème de la liberté. Dresde nous semble être la ville idéale pour cela : elle représente aussi bien la perte que la liberté retrouvée et attire par de multiples attraits en lien avec le thème de notre congrès.

Nous nous réjouissons de vous accueillir au Centre international des congrès, hôtel Maritim, pour la 38^e conférence annuelle de la FEP 2025.

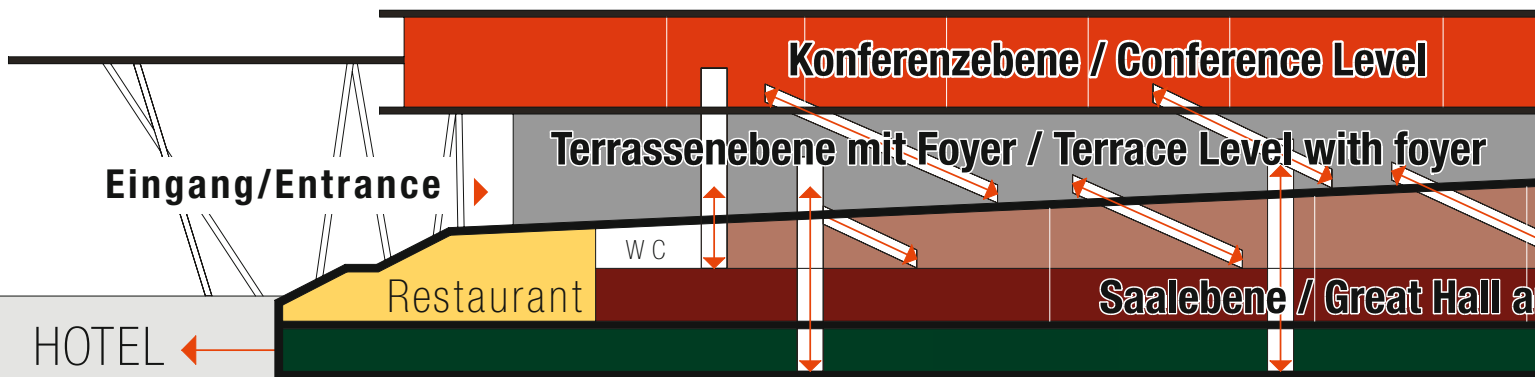

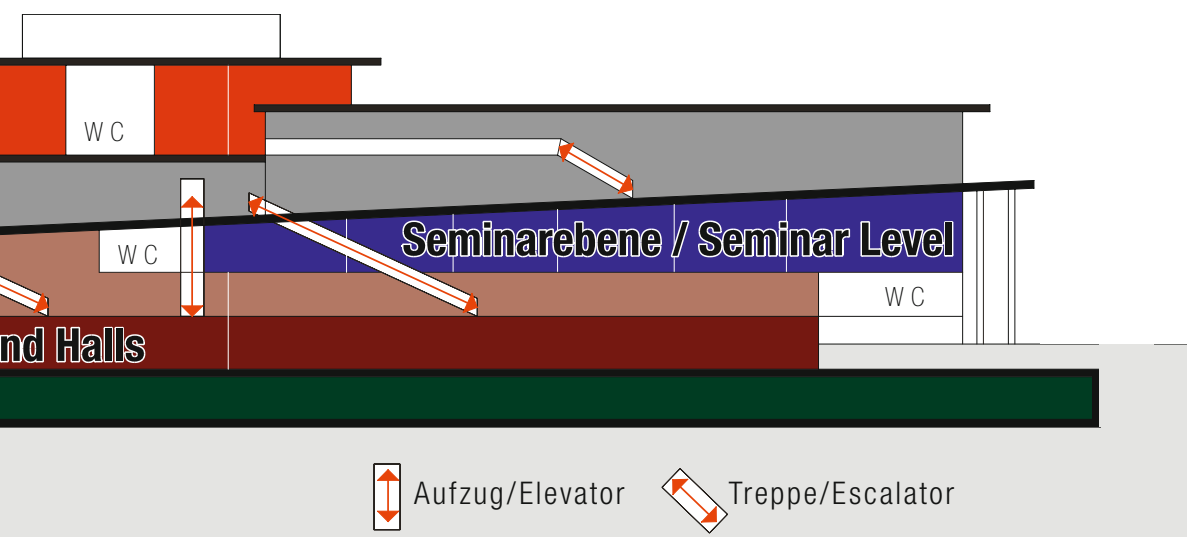
